## Federal Income Tax Delay May Not Apply To State Tax

For most taxpayers, the deadline for federal income tax filing and payment is now July 15, 2020. Florida does not have a state income tax. However, if you are a resident of another state that does, or have income from another state that does (for example, rental property) you must file a return there. You should check to see if that state has

extended its own deadline.
