The 2022 Florida Back-To-School Sales Tax Holiday kicks off July 25 and runs through August 7. During this time period you may purchase many school supplies, including computers of \$1,500 or less, free of sales tax. **Details.**

Also, children's diapers, and apparel for children 5 and younger are sales tax-free for a full year, beginning July 1, 2022 and through June 30, 2023. **Details**.
